The following are the rules and regulations for the parking garage at Vista del Sol:

1. You will be issued a parking decal upon purchase, which must be placed on the back window driver's side of your vehicle.
2. You agree to pay a parking charge of \$210.00 for non-reserved garage parking or \$240.00 for reserved garage parking per contract period. There will be no refunds for early withdrawal from Arizona State University. This parking charge is for your use of one parking space in the garage.
3. Vehicles may only be parked in designated parking spaces. Vehicles may not be parked in a fire zone, next to a dumpster, by the curb, in any reserved parking space not assigned to the resident, spaces in front of community center, retail parking meters or any place other than designated parking spaces.

4. Vehicle repairs and maintenance are not permitted in the garage.
5. We can tow any vehicle that does not have a parking decal. We can also tow any vehicle that is not parked properly in a designated parking space and/or that is in violation of these rules and regulations or other applicable rules and regulations. The owner of the vehicle will be responsible for all costs and expenses of the towing. Non reserved parking is permitted only above space #3001.
6. If at any time you switch vehicles or license plates, you need to bring the old sticker into the Vista del Sol Office to get a new one. A \$50 charge will be assessed for anyone who loses their parking sticker and requires a new one.
7. We are not responsible for theft or damage to vehicles or contents.

\*Vista del Sol parking facility is not part of the ASU parking system. Different rules and privileges do apply.
